

**Offering Circular Supplement
(To Offering Circular
Dated March 17, 2008)**

Freddie Mac Mortgage Participation Certificates

The Offering Circular is being amended as follows, effective immediately:

Under “**ADDITIONAL INFORMATION**,” the following four paragraphs replace the first two paragraphs in their entirety:

We registered our common stock with the U.S. Securities and Exchange Commission (“**SEC**”) under the Securities Exchange Act of 1934 (“**Exchange Act**”), effective July 18, 2008. As a result, we now file annual, quarterly and current reports, proxy statements and other information with the SEC. Prior to July 18, 2008, we prepared an annual Information Statement (containing annual financial disclosures and audited consolidated financial statements) and Information Statement Supplements (containing periodic updates to the annual Information Statement).

As described below, we incorporate certain documents by reference in this Offering Circular, which means that we are disclosing information to you by referring you to those documents rather than by providing you with separate copies. We incorporate by reference in this Offering Circular our proxy statement, and all documents that we file with the SEC pursuant to Section 13(a), 13(c) or 14 of the Exchange Act, after July 18, 2008 and prior to the completion of the offering of the related PCs, excluding any information that we may “furnish” to the SEC but that is not deemed to be “filed.” We also incorporate by reference our Registration Statement on Form 10, in the form declared effective by the SEC on July 18, 2008 (the “**Registration Statement**”). These documents are collectively referred to as the “**Incorporated Documents**” and are considered part of this Offering Circular. You should read this Offering Circular and any applicable Pool Supplement, in conjunction with the Incorporated Documents. Information that we incorporate by reference will automatically update information in this Offering Circular. Therefore, you should rely only on the most current information provided or incorporated by reference in this Offering Circular and any applicable Pool Supplement.

Offering Circular Supplement dated July 18, 2008

Under “**ADDITIONAL INFORMATION**,” the first sentence of the fourth paragraph is revised as follows, “This Offering Circular relates to PCs issued on and after July 18, 2008.”

Under “**DESCRIPTION OF THE MORTGAGES – Mortgage Purchase and Servicing Standards – Defaults and Delinquencies**,” the final sentence is revised as follows, “The Incorporated Documents provide information regarding our overall Mortgage delinquency, default and foreclosure experience.”

Under “**DESCRIPTION OF THE PCs – Payments of Interest – ARM PCs**,” the following sentence is added at the end of the first paragraph, “To the extent the interest rate is modified and reduced for a Mortgage underlying an ARM PC, we only guarantee the timely payment of the modified interest rate and we are not responsible for any shortfalls between the original contractual interest rate and the modified interest rate. However, generally it has been our historical practice, and is our current practice, to purchase all Mortgages out of their PC Pools at the time of modification, including Mortgages underlying ARM PCs. Depending on circumstances, we can alter this practice at any time.”

Under “**SECONDARY MARKETS, MORTGAGE SECURITY PERFORMANCE AND MARKET SUPPORT ACTIVITIES**,” the final sentence is revised as follows, “The Incorporated Documents contain additional information about our security performance and market support activities.”

In **Appendix I (INDEX OF TERMS)** to the Offering Circular, the terms “Exchange Act,” “Incorporated Documents,” “Registration Statement” and “SEC” are added in alphabetical order and the corresponding page number “4” is added in the case of each of the new terms.

Unless defined in this Supplement, capitalized terms used in this Supplement have the meanings given to them in the Offering Circular.
