Insured	Federal Home Loan Mortgage Corporation (“Freddie Mac”)
Covered Loans	Initial reference pool of \$34.70B associated with STACR 2015-DNA3. Pool includes conventional fully amortizing 30-year fixed rate first lien mortgages with original LTVs between 60%-80%, funded by Freddie Mac between December 1 st , 2014 and March 31 st , 2015.
Insurance Coverage	Credit Insurance Policy with a maximum loss limit of \$702.42M on losses related to Credit Events (as defined in the insurance policy) on STACR 2015-DNA3 Reference Tranches M-1H, M-2H, M-3H and B-H. Freddie Mac fully absorbs any losses related to Reference Tranches A-H.
Counterparties	4 International & Domestic insurance providers 6 International & Domestic reinsurers
Effective Date	November 2015
Maturity Date	April 2028
Freddie Mac Min Collateral Amount	Freddie Mac required the participating counterparties to establish collateral trust accounts that hold cash and cash equivalent securities. The aggregate minimum collateral amount required by Freddie Mac was approximately \$104.5M ¹
