Insured	Federal Home Loan Mortgage Corporation ("Freddie Mac")
Covered Loans	Initial reference pool of \$35.70B associated with STACR 2016-DNA1. Pool includes conventional fully amortizing 30-year fixed rate first lien mortgages with original LTVs between 60%-80%, funded by Freddie Mac between April 1 st , 2015 and June 30 th , 2015.
Insurance Coverage	Credit Insurance Policy with a maximum loss limit of \$450.65M on losses related to Credit Events (as defined in the insurance policy) on STACR 2016-DNA1 Reference Tranches M-1H, M-2H, M-3H and B-H. Freddie Mac fully absorbs any losses related to Reference Tranches A-H.
Counterparties	4 International & Domestic insurance providers 9 International & Domestic reinsurers
Effective Date	January 2016
Maturity Date	July 2028
Freddie Mac Min Collateral Amount	Freddie Mac required the participating counterparties to establish collateral trust accounts that hold cash and cash equivalent securities. The aggregate minimum collateral amount required by Freddie Mac was approximately \$71.9M ¹
