Agency Credit Insurance Structure 2017-ARMR1
Insurance Policy A and Insurance Policy B
(“ACIS 2017-ARMR1”)

Insured	Federal Home Loan Mortgage Corporation (“Freddie Mac”)
Covered Loans	Initial reference pool of \$15.0B associated with STACR 2017-HRP1. Pool includes reference obligations that were all originated in accordance with Freddie Mac’s Relief Refinance Mortgage offering. Pool includes first-lien conventional mortgage loans owned or securitized with original LTVs greater than 60% and less than or equal to 150%, acquired by Freddie Mac between March 13, 2009 and December 31, 2011.
Insurance Coverage	Credit Insurance Policy with a maximum loss limit of \$285.1M on losses related to Credit Events (as defined in the insurance policy) on STACR 2017-HRP1. Reference Tranches M-2H, B-1H and B-2H. Freddie Mac fully absorbs any losses related to Reference Tranches A-H and M-1H.
Counterparties	2 International & Domestic insurance providers 5 International & Domestic reinsurers
Effective Date	December 13, 2017
Initial Maturity Date	June 2030
Extended Maturity Date	December 2042
Freddie Mac Min Collateral Amount	Freddie Mac required the participating counterparties to establish collateral trust accounts that hold cash and cash equivalent securities. The aggregate minimum collateral amount required by Freddie Mac was approximately \$51.4M ¹
