Agency Credit Insurance Structure 2020-HQA2
Insurance Policy A and Insurance Policy B
(“ACIS 2020-HQA2”)

Insured	Federal Home Loan Mortgage Corporation (“Freddie Mac”)
Covered Loans	Initial reference pool of \$35.1B associated with STACR 2020-HQA2. Pool includes conventional fully amortizing 20-year to 30-year fixed rate first lien mortgages with original LTVs greater than 80% and less than or equal to 97%. The Reference Obligations are mortgage loans that were acquired between July 1, 2019 and September 30, 2019.
Insurance Coverage	Aggregate Excess of Loss Credit Insurance Policy with a maximum loss limit of \$293M on losses related to Credit Events (as defined in the insurance policy). Reference Tranches M-1H, M-2H, B-1H and B-2H. Freddie Mac fully absorbs any losses related to Reference Tranches A-H and B-3H.
Counterparties	1 International & Domestic insurance providers 13 International & Domestic reinsurers
Effective Date	March 18, 2020
Maturity Date	September 2032
Freddie Mac Min Collateral Amount	Freddie Mac required the participating counterparties to establish collateral trust accounts that hold cash and cash equivalent securities. The aggregate minimum collateral amount required by Freddie Mac was approximately \$65.2M ¹ .
