Insurance Policy A and Insurance Policy B
(“ACIS 2022–SPL1”)

Insured	Federal Home Loan Mortgage Corporation (“Freddie Mac”)
Covered Loans	Initial reference pool of \$22.2B includes conventional fully amortizing 20-year to 30-year fixed rate first lien mortgages with original LTVs less than 80%. The Reference Obligations are mortgage loans acquired between September 1, 2021 and September 30, 2021.
Insurance Coverage	Aggregate Excess of Loss Credit Insurance Policy with a maximum loss limit of \$897.4M on losses related to Credit Events (as defined in the insurance policy). Reference Tranches M-1, M-2, B-1, and B-2. Freddie Mac fully absorbs any losses related to Reference Tranches A & B-3.
Counterparties	2 International & Domestic insurance providers 28 International & Domestic reinsurers
Effective Date	January 28, 2022
Maturity Date	July 2034
Freddie Mac Min Collateral Amount	Freddie Mac required the participating counterparties to establish collateral trust accounts that hold cash and cash equivalent securities. The aggregate minimum collateral amount required by Freddie Mac was approximately \$161M ¹
