

**Summary of Terms**  
**Agency Credit Insurance Structure 2023–SPL2**  
**Insurance Policy A**  
**(“ACIS 2023–SPL2”)**

<b>Insured</b>	Federal Home Loan Mortgage Corporation (“Freddie Mac”)
<b>Covered Loans</b>	Initial reference pool of \$7.1B includes conventional fully amortizing 20-year to 30-year fixed rate first lien mortgages with original LTVs greater than 61% and less than or equal to 80%. The Reference Obligations are mortgage loans that were securitized in Freddie Mac’s PCs between September 1, 2022 and September 30, 2022.
<b>Insurance Coverage</b>	Aggregate Excess of Loss Credit Insurance Policy with a maximum loss limit of \$254.6M on losses related to Credit Events (as defined in the insurance policy). Reference Tranche A-1, M-1, M-2, and B-1. Freddie Mac fully absorbs any losses related to Reference Tranches A, B-2 & B-3.
<b>Counterparties</b>	27 International & Domestic reinsurers
<b>Effective Date</b>	May 25, 2023
<b>Maturity Date</b>	November 2035
<b>Freddie Mac Min Collateral Amount</b>	Freddie Mac required the participating counterparties to establish collateral trust accounts that hold cash and cash equivalent securities. The aggregate minimum collateral amount required by Freddie Mac was approximately \$41.1M <sup>1</sup>
