Insurance Policy A
(“ACIS 2025–SPH4”)

Insured	Federal Home Loan Mortgage Corporation (“Freddie Mac”)
Covered Loans	Initial reference pool of \$9.4B includes conventional fully amortizing 20-year to 30-year fixed rate first lien mortgages with original LTVs greater than 80% and less than or equal to 97%. The Reference Obligations are mortgage loans that were securitized in Freddie Mac’s PCs between December 1, 2024 and December 31, 2024.
Insurance Coverage	Aggregate Excess of Loss Credit Insurance Policy with a maximum loss limit of \$293.3M on losses related to Credit Events (as defined in the insurance policy). Reference Tranche A-1, M-1, and M-2. Freddie Mac fully absorbs any losses related to Reference Tranches A, B-1, B-2 & B-3.
Counterparties	23 International & Domestic reinsurers
Effective Date	July 25, 2025
Maturity Date	July 2045
Freddie Mac Min Collateral Amount	Freddie Mac required the participating counterparties to establish collateral trust accounts that hold cash, cash equivalent securities, and other eligible securities. The aggregate minimum collateral amount required by Freddie Mac was approximately \$43.9M ¹
